PGME RESIDENT REIMBURSEMENTS UPDATE

Special Approval Process for Resident Reimbursement Submission:

PGME has implemented a special approval process to accept email approval/electronic signatures and scanned or photo supporting documentation for resident reimbursement claims during UBC's COVID-19 response. Please see the <u>PGME website</u> for more details.

Updated mileage grid:

RESIDENT WELLNESS OFFICE (RWO) UPDATES

Counsellor availability updates:

In these uncertain and challenging times, Resident health and safety is our number one concern. For this reason, the PGME Resident Wellness Office has made the decision to suspend any in-person counselling appointments for the time being. We will resume in-person counselling as quickly as possible, when it is safe to do so. All counselling appointments will be facilitated via telephone or videoconference. Counsellors will be working varied hours at this time, including more evening appointments. If residents currently have an appointment booked, their counsellor will be in touch to reschedule.



Group Support Updates:

Given the nature of Ice Cream Rounds, this type of group support session can only be facilitated in person. At this time we are very tentatively keeping all scheduled group support sessions scheduled after Friday April 3rd as is. However, given the constantly evolving updates on COVID- 19, we recognize that this position may change. If it is not safe for groups of residents to meet in person, we will cancel all Ice Cream Rounds and will look forward to rescheduling an Ice Cream Rounds session with your program in the new academic year. We will work to provide updates ongoing as we receive updates and guidance from PGME.
